

SPANISH BROADCASTING SYSTEM- Standard Call In To Win Rules

Official Rules and Regulation

1. No purchase necessary.

2. WHO MAY PARTICIPATE:

Listener must be 18 years of age or older unless indicated by the individual contest. Must have either a valid social security number and card, or a valid Taxpayer Identification Number.

3. ELIGIBILITY

- A. Employees of Radio Stations WLEY-FM (“Station”), Spanish Broadcasting System, Inc., its affiliates and their public relations agencies, participating sponsors and family members (family is defined as spouse, parents, children, sibling, aunts, uncles, cousins and grandparents) are ineligible.
- B. One prize per winner and his/her immediate family (family is defined as spouse, parents, children, sibling, aunts, uncles, cousins and grandparents) and or/household (household is defined as anyone living at the same address) is allowed within a sixty (60) day period.
- C. Any individual who wins \$600 or more in one calendar year from WLEY-FM will be required to present a valid social security card or a valid taxpayer identification number (“TIN”) and a valid government-issued photo ID which contains the individual’s current address. Failure to present a valid social security card or TIN may result in a disqualification of the winner, in which case the prize shall be forfeited.
- D. **If the winner selected is later determined by the station to be ineligible, no prize will be awarded to the ineligible contestant and WLEY-FM reserves the right to award the prize to a qualified contestant.**

4. NATURE OF CONTEST:

Listeners will be asked to call in on the listener lines to Station and be the correct numbered caller. The on-air personality will determine the numbered call sought. The contestant may be asked to participate in an additional manner, such as, but not limited to, singing the Station jingle or answering a trivia question, to win. Station shall have no responsibility for any claimed failure or inability to participate, win and/or claim any prize based on allegations of telephone problems.

5. PRIZES:

As indicated on-air by the announcer; prizes will vary per contest.

6. RETAIL VALUE:

The approximate retail value of the Prize varies up to \$1,000.

7. ODDS OF WINNING.

The odds of winning depends on the number of online entries.

8. RESPONSIBILITY:

Station, Spanish Broadcasting System and participating sponsors will not be responsible for any claims, liabilities, losses, repairs, damage or injuries arising out of or in conjunction with the services, merchandise or other benefits obtained by the winner or this contest.

9. REDEEMING OF PRIZE:

All prizes must be redeemed or claimed within ten (10) business days at, 150 N. Michigan Ave, Suite 1040, Chicago, IL 60601 Monday through Friday between the hours of 10:00 AM to 4:00 PM.

10. RELEASE:

All winners must sign a release permitting reasonable use for promotional purposes and all media of the participants, name, likeness and biographical information, and releasing Station, Spanish Broadcasting System, Inc. and its affiliates and sponsors from any and all claims, liabilities and damages arising directly or indirectly out of the award of the prize or that may be sustained directly or indirectly in connection with this contest.

11. Any tax, licensing, registration fee or additional expenses incurred as a result of the prize are the sole responsibility of the winner.

12. Prizes may not be substituted or exchanged for cash.

13. Station reserves the right to award additional prizes throughout the contest.

14. Any rule changes after the contest begins must not disadvantage contest participants and will be announced promptly and conspicuously.

15. The name of the listener that appears on the official/original contest sheet is the winner of that particular contest. Prizes are not transferable and cannot be sold.

16. All questions concerning the interpretation of these rules should be directed to the Station's General Manager whose decision will be final.
